RESOLUTION AUTHORIZING THE COUNTY OF WESTCHESTER TO ENTER INTO AN AGREEMENT WITH THE NEW YORK STATE DIVISION OF CRIMINAL JUSTICE SERVICES IN AN AMOUNT NOT TO EXCEED \$727,400 IN STATE FUNDS AND \$2,205,095 IN COUNTY MATCHING FUNDS FOR THE DISTRICT ATTORNEY'S OFFICE TO OPERATE THE AID TO PROSECUTION PROGRAM FOR THE PERIOD APRIL 1, 2010 THROUGH MARCH 31, 2011, PURSUANT TO AN APPROVED BUDGET AND SUBJECT TO COUNTY APPROPRIATION.

Authority is sought for the County of Westchester to enter into a Grant Award Agreement with the New York State Division of Criminal Justice Services in an amount not to exceed \$727,400 in State Funds and \$2,205,095 in County Matching funds for the District Attorney's Office to operate the Aid to Prosecution Program for the period April 1, 2010 through March 31, 2011, pursuant to an approved budget and subject to County appropriation.

The Aid to Prosecution Grant promotes the general welfare and public safety of the citizens of the County by expediting the arrest and prosecution of felony offenders charged with violent felony offenses, persistent felony offenders charged with non-violent felony offenses and other serious felony offenders, thereby helping to make the County a safer place. The goals and objectives of the Aid to Prosecution Grant are monitored by the District Attorney's Office and quarterly reports are submitted to DCJS for their review and approval.

The requirements of the Westchester County Procurement Policy were followed. The procurement is exempt under Section 3(a) iii of the procurement policy which provides for the exception "transactions or contracts with the United States of America, any State agency ..." This agreement is a transaction/contract with the New York State Division of Criminal Justice Services.

RESOLUTION

Upon a communication from Janet DiFiore, District Attorney, be it hereby,

RESOLVED, that authority is granted to the County of Westchester to enter into an agreement with the New York State Division of Criminal Justice Services in an amount not to exceed \$727,400 in State Funds and \$2,205,095 in County matching funds for the District Attorney's Office to operate the Aid to Prosecution Program for the period April 1, 2010 through March 31, 2011, pursuant to an approved budget; and be it further,

RESOLVED, that the District Attorney's Office or her duly authorized designee be and hereby is authorized and empowered to enter into this agreement for the County of Westchester.
