On June 16, 2010, eleven (11) bids were received and opened for Contract No. 07-564 for Purchase Street Water and Hangar E Sewer Replacement, Westchester County Airport, Towns of Harrison and North Castle, and Village of Rye Brook, New York.

The bids were reviewed by the Department and it was determined that R. Pagni & Sons, Inc. submitted the low bid in the amount of \$1,405,012.50.

The low bidder has been investigated and it has been found that R. Pagni & Sons, Inc.:

- Performed satisfactory work in the past for the County.
 Past experience has been investigated and found satisfactory.

The objective of this contract is to upgrade existing utilities at the Airport.

This contract is in the public's best interest because it will promote the health and safety of the general public by providing new water and sewer mains that meet current State and Health Department codes and standards, thus addressing the County Executive's priority area: Health and the Environment (HE). There are no energy or environmental components associated with this project.

If this resolution is not approved, the existing water and sewer mains could potentially fail, resulting in the need for emergency repairs.

The department will utilize Primavera Software Management tools to track scheduling and accomplishments by the contractor and perform on-site inspections to ensure the successful completion of this project.

It is my recommendation that Contract No. 07-564 be awarded to R. Pugni & Sons, Inc. in the amount of \$1,405,012.50.

Payment for this contract will be made from the Airport Special Revenue Fund, not the County General Fund and will not impact the County tax levy.
