On June 16, 2010, ten (10) bids were received and opened for Contract No. 10-510 for Safety Improvements Between Runway 16-34 and Taxiway K, Westchester County Airport, Towns of Harrison and North Castle, and Village of Rye Brook, New York.

The bids were reviewed by the Department and it was determined that DiMarino Brothers Contracting, Inc. submitted the low bid in the amount of \$117,378.55.

The low bidder has been investigated and it has been found that DiMarino Brothers Contracting, Inc.:

- Performed satisfactory work in the past for the County.  
 Past experience has been investigated and found satisfactory.

Funds for this project are available in the:

- Capital Budget  
 Non-Recurring Budget  
 Operating Budget

The objective of this contract is to improve the airfield safety area between Runway 16-34 and Taxiway K.

This contract is in the public's best interest because it will promote the health and safety of the general public by improving airfield safety to meet FAA safety standards, thus addressing the County Executive's priority area: Safety and Security (SS). There are no energy or environmental components associated with this project.

If this resolution is not approved, the Westchester County Airport will not be in compliance with FAA safety standards.

The department will utilize Primavera Software Management tools to track scheduling and accomplishments by the contractor and perform on-site inspections to ensure the successful completion of this project.

It is my recommendation that Contract No. 10-510 be awarded to DiMarino Brothers Contracting, Inc. in the amount of \$117,378.55.

Payment for a portion of this contract will be made from the Airport Special Revenue Fund, not the County General Fund and will not impact the County tax levy.
