Re: **Authority to enter into a grant disbursement agreement with the Dormitory Authority of the State of New York, to purchase Digital Age Community Based Intelligence Equipment for a three (3) year term commencing upon execution, with a State option to extend the term for one (1) year, in an amount not to exceed One Hundred Thousand (\$100,000.00) Dollars**

Attached for your consideration is a Resolution which, if approved by your Honorable Board, would authorize the County of Westchester, acting by and through the Westchester County District Attorney's Office ("District Attorney's Office"), to enter into a grant disbursement agreement with the Dormitory Authority of the State of New York ("DASNY") to purchase Digital Age Community Based Intelligence Equipment to be used to investigate homicides, robberies, burglaries, gang crimes, firearms crimes, narcotics trafficking and possession crimes, organized crime, economic crimes, internet crimes, child, sexual and elder abuse crimes, etc. The term of the agreement shall commence upon execution and continue for three (3) years. DASNY, may, in its sole discretion, extend the term of the agreement for one (1) year upon a showing by the County that the project is under construction and is expected to be completed within the additional one (1) year term. DASNY shall make payments directly to the County in the amount actually incurred, up to an amount not to exceed One Hundred Thousand (\$100,000.00) Dollars, upon presentation to DASNY of an invoice, together with supporting documentation.

The proposed agreement is in the public's best interest and will promote the safety and general welfare of the public by providing high technological equipment that will advance investigations and enable the District Attorney's Office to successfully prosecute cases within the criminal justice system.

The goals and objectives of this program are the reduction in the crime rate throughout Westchester County and the enhancement of the public safety of the County's residents.

The District Attorney's Office is required under the grant disbursement agreement to provide proof of disbursement of the grant funds and will monitor the effectiveness of this agreement through a series of performance measures required by DASNY.

Accordingly, authority is respectfully sought for the County to enter into this Agreement.

RESOLUTION

Upon a communication from the District Attorney, it is hereby

RESOLVED, that the District Attorney or her duly authorized designee is authorized and empowered to execute and deliver all instruments and take all actions necessary or appropriate to effectuate the purposes hereof.
