SUBJECT: Resolution Authorizing an Amendment to the Agreement between the County of Westchester and the Village of Dobbs Ferry to Change the Expiration Date for a Sidewalk Improvement Project at the Intersection of Livingston Avenue and Broadway in the Village of Dobbs Ferry

On May 28, 2009, your Honorable Board approved the resolution authorizing the County of Westchester to enter into an agreement with the Village of Dobbs Ferry for a Sidewalk Improvement Project at the Intersection of Livingston Avenue and Broadway. The amount of the grant is \$150,000.00, from the Community Development Block Grant Program.

The attached resolution authorizes the County of Westchester to amend the agreement with the Village of Dobbs Ferry for the Sidewalk Improvement Project at the Intersection of Livingston Avenue and Broadway in the Village of Dobbs Ferry in order to change the expiration date from May 30, 2010 to May 30, 2012. All other terms and conditions will remain the same.

The Village of Dobbs Ferry is requesting to extend the expiration date of the agreement as there were New York State budgetary delays and the Village was not certain when they would receive approval from the New York State Department of Transportation for their request for a time extension.

The agreement will serve the public purpose of providing a safe walkway and handicap accessibility in the Village of Dobbs Ferry.

The goal and objective of the agreement is to ensure public safety and handicap accessibility by replacing hazardous sidewalk conditions for pedestrians in the Village of Dobbs Ferry. The project will be monitored by the Department of Planning staff during bi-monthly site visits.

I recommend approval of this amendment.
