On July 21, 2010, thirteen (13) bids were received and opened for Contract No. 10-215 for Replacement of Security Culvert, Westchester County Airport, Towns of Harrison and North Castle and Village of Rye Brook, New York.

The bids were reviewed by the Department and it was determined that R. Pugni & Sons, Inc. submitted the low bid in the amount of \$98,230.00.

The low bidder has been investigated and it has been found that R. Pugni & Sons, Inc.:
