JET BRIDGE SERVICE AND MAINTENANCE
WESTCHESTER COUNTY AIRPORT

Attached for your consideration is a Resolution which, if approved by your Honorable Board, would authorize the Department of Transportation to solicit bids by public advertisement for the above referenced project.

The work under this contract will consist of all necessary labor, materials and equipment for the maintenance of the Passenger Jet Bridges at the Westchester County Airport for a period of three (3) years commencing February 1, 2011 and ending January 31, 2014.

This contract will benefit the public by maintaining the jet bridges in a safe and proper working order for enplaning and deplaning passengers on a daily basis. The goals and objectives are to maintain the equipment in a safe manner and to reduce down time for major mechanical failures through scheduled maintenance. There are no energy or environmental components associated with this contract.

Airport Administration will oversee the contract, and all service visits must be accompanied with written documentation of the work performed. Payment will only be made upon receipt of invoices and verification of service dates and maintenance tickets.

Payment for this contract will be made from the Airport Special Revenue Fund, not the County General Fund and will not impact the County tax levy.

A proposed resolution to authorize the bid advertisement is attached for your consideration.

Upon communication from the Acting Commissioner of Transportation, be it

RESOLVED, that the Acting Commissioner of Transportation be and he hereby is authorized to solicit bids by public advertisement on the following contract:

and be it further

RESOLVED, that this service contract will be for a period of three (3) years commencing February 1, 2011 and ending January 31, 2014; and be it further

RESOLVED, that adequate and sufficient security for the faithful performance of this contract shall be deemed to be receipt of a performance and payment bond in an amount equal to 30% of the total contract amount, and in a form approved by the County Attorney. The Bond Underwriter or Surety must appear on the US Treasury's listing of approved sureties (Department Circular 570) and all Sureties must be licensed to transact business in New York as a surety company; and be it further

RESOLVED, that this advertisement for bids will state that pursuant to Chapter 308 of the Laws of the County of Westchester, the policy of the County is to encourage the meaningful and significant participation on County contracts for business enterprises owned by persons of color and women – Minority Business Enterprise (MBE) and Women Business Enterprise (WBE); and be it further
