The 2010 Capital Budget contains funds for the above referenced project.

The work under this contract consists of providing all necessary labor, material and equipment required to re-grade channel streambanks and to install stone weirs, check dams and planting of native wetland species.

The objective of this contract is to stabilize streambanks and create a wetland area adjacent to an existing stormwater outflow channel located in Scout Field Park.

This contract is in the public's best interest because it will provide an environmental benefit by reducing flooding and erosion, thus addressing the County Executive's priority area: Health and the Environment (HE).

The department will track scheduling and accomplishments by the contractor and perform on-site inspections to ensure the successful completion of this project.

Payment for a portion of this contract will be made from the National Fish and Wildlife Foundation, not the County General Fund and will not impact the County tax levy.
