The 2010 Capital Budget contains funds for the above referenced project.

The work under this contract consists of providing all necessary labor, material and equipment required to install new foundations for vendor supplied and installed water slides. Also included is the installation of a new slide landing pool and connection to the facilities' water filtration system.

The objective of this contract is to complete the planned water park facility.

This contract is in the public's best interest because it will promote the health and safety of the general public by providing water park facilities meeting current State and Health Department codes and standards, thus addressing the County Executive's priority area: Health and the Environment (HE). Additionally, it is projected that revenues will increase, thus addressing the County Executive's priority area: Fiscal Responsibility (FR).

The project will provide energy savings by the use of state-of-the-art water filtration systems.

The department will track scheduling and accomplishments by the contractor and perform on-site inspections to ensure the successful completion of this project.
