On November 17, 2010, ten (10) bids were received and opened for Contract No. 09-553 for Active Recreation Improvements, Sprain Ridge Park and Tibbetts Brook Park, City of Yonkers, New York.

The bids were reviewed by the Department and it was determined that Pat Corsetti, Inc. submitted the low bid in the amount of \$803,174.50.

The low bidder has been investigated and it has been found that Pat Corsetti, Inc.:

- Performed satisfactory work in the past for the County.  
 Past experience has been investigated and found satisfactory.

The objective of this contract is to replace and upgrade recreational equipment that has reached the end of its useful life.

This contract is in the public's best interest because it will provide new picnic and playground equipment that meets current safety guidelines, thus addressing the County Executive's priority area: Safety and Security (SS).

This project will provide an environmental benefit by improving the quality of stormwater runoff and eliminating erosion.

The department will track scheduling and accomplishments by the contractor and perform on-site inspections to ensure the successful completion of this project.

It is my recommendation that Contract No. 09-553 be awarded to Pat Corsetti, Inc. in the amount of \$803,174.50.
