The 2010 Capital Budget contains funds for the above referenced project.

The work under this contract consists of providing all necessary labor, material and equipment required to repave walkways and install new ADA accessible drop curbs. The project also includes installation of new pavement markings, signage, lighting, bollards, benches, bicycle racks and landscaping.

The objective of this contract is to provide more efficient and accessible pedestrian and bicycle access to the TransCenter facility.

This contract is in the public's best interest because it will promote the health and safety of the general public by ensuring that pedestrian access to the TransCenter meets current codes and standards, thus addressing the County Executive's priority area: Safety and Security (SS). There are no energy or environmental components associated with this project.

The department will track scheduling and accomplishments by the contractor and perform on-site inspections to ensure the successful completion of this project.

Payment for this contract will be made from the Federal Transit Administration, not the County General Fund and will not impact the County tax levy.
