RE: Authority to extend the license agreement with Saxon Restaurant Corporation, 315 Mamaroneck Avenue, Scarsdale, New York 10583 for the operation of the food and refreshment concession at Mohansic Golf Course, Yorktown Heights, New York for the period of January 1, 2011 through December 31, 2011

By Resolution dated March 23, 2006, the Board of Acquisition and Contract granted authority to enter into a license agreement with Saxon Restaurant Corporation, 315 Mamaroneck Avenue, Scarsdale, New York 10583 for the operation of the food and refreshment concession at Mohansic Golf Course, Yorktown Heights, New York for the period of March 23, 2006 through December 31, 2010, with the sole option of the County to extend the agreement for an additional period of five years for a license fee to be negotiated. Authority is now requested to extend the agreement from January 1, 2011 through December 31, 2011.

Saxon Restaurant Corporation has successfully served golfers at Mohansic Golf Course and the Department recommends extending the license agreement.

Saxon Restaurant Corporation will pay to the County a license fee of \$23,100.

The goal of this agreement is to provide revenue for the County and food and refreshment services for golfers. The objective of this agreement will be tracked and monitored by observations and interactions with staff and site visits.

This agreement is exempt from the Westchester County procurement policy pursuant to Section 3(b), thereof.

Accordingly, approval of the attached resolution by your Honorable Board is most respectfully requested.

RESOLUTION

Upon a communication from the Commissioner of Parks, Recreation and Conservation, be it hereby

RESOLVED, that the County of Westchester is hereby authorized to exercise the option to extend the license agreement with Saxon Restaurant Corporation, 315 Mamaroneck Avenue, Scarsdale, New York 10583 for the operation of the food and refreshment concession at Mohansic Golf Course, Yorktown Heights, New York for the period of January 1, 2011 through December 31, 2011; and be it further

RESOLVED, that for the privilege of operating the food and refreshment concession, Saxon Restaurant Corporation will pay to the County a license fee of \$23,100; and be it further

RESOLVED, that the County Executive or his authorized designee is hereby authorized to execute all instruments necessary to implement this Resolution.
