Authority is requested to advertise for bids for Pest Control/Exterminating Service, Various Parks, Recreation and Conservation Locations in Westchester County, New York for a period of five years. The work under this contract will consist of providing all necessary labor, material and equipment required for providing pest control/exterminating services to control insects and rodents at various Parks, Recreation and Conservation facilities.

The objective of this contract is to treat and control insects and rodents at Department of Parks, Recreation & Conservation facilities. This agreement will benefit the public as it will ensure the prompt treatment of pests thereby promoting the health and safety of the attending public. The objective of this agreement will be monitored through service reports and interaction with facility staff members.

The 2011 Operating Budget contains funds for the above referenced project.

Upon communication from the Commissioner of Parks, Recreation and Conservation, be it hereby

RESOLVED, that the Department of Parks, Recreation and Conservation is authorized to solicit bids by public advertisement on the following contract:

and be it further

RESOLVED, that adequate and sufficient security for the faithful performance of this contract shall be deemed to be receipt of a performance and payment bond in an amount equal to 30% of the total contract amount, and in a form approved by the County Attorney. The Bond Underwriter or Surety must appear on the U.S. Treasury's listing of approved sureties (Department Circular 570) and all Sureties must be licensed to transact business in New York as a surety company; and be it further

RESOLVED, that this advertisement for bids will state that pursuant to Chapter 308 of the Laws of the County of Westchester, the policy of the County is to encourage the meaningful and significant participation on County contracts for business enterprises owned by persons of color and women - Minority Business Enterprise (MBE) and Women Business Enterprise (WBE); and be it further
