RE: Authority to enter into a license agreement with Tolve Amusements, Inc.,

251 Forest Avenue, Rye, New York 10580 for the operation of a minimum of six electronic games known as "Crane Games" at Playland Ice Casino,

Rye, New York 10580 for a term commencing March, 1, 2011 and

terminating May 6, 2012

Authority is requested of this Board to enter into a license agreement with Tolve Amusements, Inc., 251 Forest Avenue, Rye, New York 10580 for the operation of a minimum of six electronic games known as "Crane Games" (coin operated machines providing various small toys to the player) at Playland Ice Casino, Rye, New York 10580 for a term commencing March 1, 2011 and terminating May 6, 2012.

As consideration for this license privilege, Tolve Amusements, Inc. will pay the County of Westchester, thirty-five percent (35%) of the gross receipts or a minimum of five hundred dollars (\$500), whichever is greater, for each month of the agreement.

The goal and objective of this agreement is to increase County revenue while providing entertainment for Ice Casino patrons. If this agreement were not in place, the "Crane Games" would not be available for patron use. The County would also lose revenue as a result of the games not being open.

The objective of this agreement will be monitored using site visits and revenue reports.

This agreement is exempt from the County's procurement policy pursuant to Section 3(b).

## RESOLUTION

Upon a communication from the Commissioner of the Department of Parks, Recreation and Conservation, be it hereby

**RESOLVED,** that the County of Westchester is authorized to enter into a license agreement with Tolve Amusements, Inc., 251 Forest Avenue, Rye, New York 10580 for the operation of a minimum of six electronic games known as "Crane Games" (coin operated machines providing various small toys to the player) at Playland Ice Casino, Rye, New York 10580 for a term commencing March 1, 2011 and terminating May 6, 2012; and be it further

**RESOLVED,** that for this license privilege, Tolve Amusements, Inc. will pay the County of Westchester thirty-five percent (35%) of the gross receipts or a minimum of five hundred dollars (\$500), whichever is greater, for each month of the agreement; and be it further

**RESOLVED,** that the County Executive or his authorized designee is hereby empowered to execute any and all instruments and take such other actions as may reasonably be necessary to effectuate the purposes thereof.
