On January 5, 2011, six (06) bids were received and opened for Contract No. 10-567 for Pool Modernization – Phase II, Tibbetts Brook Park, Yonkers, New York.

The bids were reviewed by the Department and it was determined that DiMarino Brothers Contracting, Inc. submitted the low bid in the amount of \$619,000.00.

The low bidder has been investigated and it has been found that DiMarino Brothers Contracting, Inc.:

- Performed satisfactory work in the past for the County.
 Past experience has been investigated and found satisfactory.

The objective of this contract is to complete the planned water park facility.

This contract is in the public's best interest because it will promote the health and safety of the general public by providing water park facilities meeting current State and Health Department codes and standards, thus addressing the County Executive's priority area: Health and the Environment (HE). Additionally, it is projected that revenues will increase thus addressing the County Executive's priority area: Fiscal Responsibility (FR).

The project will provide energy savings by the use of state-of-the-art water filtration systems.

The department will track scheduling and accomplishments by the contractor and perform on-site inspections to ensure the successful completion of this project.

It is my recommendation that Contract No. 10-567 be awarded to DiMarino Brothers Contracting, Inc. in the amount of \$619,000.00.
