The 2011 Operating Budget for Contractual Services contains sufficient funds for the above referenced project.

The work to be performed under this Contract consists of the emergency repair of leaks on County owned sewer and water mains as they occur in various locations throughout Westchester County, for a period of three (3) consecutive years, subject to appropriations. The Contract may be extended by mutual consent of the Contractor and the County of Westchester for one (1) additional three year term with all prices, terms and conditions remaining the same as in the original contract.

The goal and/or objective of this contract is for a prompt response to a sewer system or water system failure which requires an immediate repair on a 24/7 basis. The response and repair work are monitored by representatives of the department throughout the emergency to make sure all applicable regulations, safety precautions and codes regarding the protection of persons and property are adhered to and that a cost-effective project is the end product.
