RE: AUTHORITY TO ENTER INTO A LICENSE AGREEMENT WITH
PETER AND FREDERICKA TRAHANAS, 4 MANHATTAN AVENUE,
RYE, NEW YORK 10580 TO OPERATE THREE GAME CONCESSIONS
AT PLAYLAND PARK FOR THE 2011 OPERATING SEASON
FOR A TERM COMMENCING MAY 1, 2011 AND TERMINATING
OCTOBER 31, 2011

Authority is requested of this Board for the County of Westchester to enter into a license agreement with Peter and Fredericka Trahanas, 4 Manhattan Avenue, Rye, New York 10580 to operate three game concessions at Playland Park, Rye, New York for the 2011 operating season for a term commencing May 1, 2011 and terminating October 31, 2011.

As consideration for this license privilege, Peter and Fredericka Trahanas will pay the County of Westchester a license fee of \$30,000 plus \$0.12 per person for each guest over 480,000 for the 2011 operating season.

The goal and objective of this agreement is to increase County revenue while providing game concessions for Playland patrons. If this agreement were not in place, the game concessions would not be available for patron use. This would result in disappointed customers who have become accustomed to visiting these attractions. The County would also lose revenue as a result of these games not being open.

The objective of this agreement will be monitored using inspection and revenue reports.

This agreement is exempt from the County's procurement policy pursuant to Section 3 (b).

A Resolution is attached for your favorable consideration.

RESOLUTION

Upon a communication from the Commissioner of the Department of Parks, Recreation and Conservation, be it hereby

RESOLVED, that the County of Westchester is authorized to enter into a license agreement with Peter and Fredericka Trahanas, 4 Manhattan Avenue, Rye, New York 10580 to operate three game concessions at Playland Park, Rye, New York for the 2011 operating season for a term commencing May 1, 2011 and terminating October 31, 2011; and be it further

RESOLVED, that for this license privilege, Peter and Fredericka Trahanas will pay the County of Westchester a license fee of \$30,000 plus \$0.12 per person for each guest over 480,000 for the 2011 operating season; and be it further

RESOLVED, that the County Executive or his duly authorized designee is hereby empowered to execute any and all instruments and take such other actions as may reasonably be necessary to effectuate the purposes thereof,
