Resolution for Authority to Advertise for transportation services for children SUBJECT:

Attached for your consideration is a Resolution which, if approved by your Honorable Board, would authorize the Department of Social Services ("DSS") to solicit bids by public advertisement for the above referenced project.

The work under this project will consist of all necessary labor, materials and equipment to provide transportation services to Department of Social Services customers, specifically foster children ages 0 to 21, for court mandated family and sibling visitation. The work will include providing transportation from the foster home, relative home, or school to the designated visitation location and back to the foster or relative home throughout the County, as needed, for a period of one-year period commencing on or about June 1, 2011 with the County's option to extend for five (5) additional one-year periods.

The goals and objectives of this contract are to provide transportation services for children placed under Article 1017, Article 1055 or children currently in foster care to transport them to and from court ordered visitation with custodial and/or non-custodial caretakers.

The goals and objectives are in the best interest of the County in terms of public health and safety of the children of Westchester County. Visitation allows for the preservation and strengthening of parent-child relationships, as well as, serving as a strategy for reunifying families and achieving permanency. Visitation also reduces the negative effects of separation for the child and the parent.

DSS will track and monitor these services to evaluate success through the monitoring of reports submitted by the vendor, and making onsite visits.

An appropriate resolution to authorize the bid advertisement is attached for your consideration.

Treasury's listing of approved sureties (Department Circular 570) and be licensed to transact business in New York as a surety company, and be it further
