SUBJECT: Resolution authorizing the County of Westchester to enter into an Intermunicipal Agreement with the City of Yonkers to administer the Housing Opportunities for Persons With AIDS (HOPWA) Program in the City of Yonkers

The attached resolution authorizes the County of Westchester to enter into an Intermunicipal Agreement (IMA) with the City of Yonkers for the purpose of administering the Housing Opportunities for Persons With AIDS (HOPWA) Program. This agreement will provide funding from the Fiscal Year 2010 Federal HOPWA Program for services that will benefit Yonkers residents. The amount of the agreement is \$357,000.00, pursuant to an approved budget. The term of the agreement is January 1, 2011 to December 31, 2011.

The agreement will serve the public purpose of providing public health services to persons with AIDS.

The goal and objective of this agreement is to assist persons with HIV/AIDS and their families with case management services and rental subsidies to secure permanent affordable housing. Under last year's agreement, the City of Yonkers assisted a total of 160 persons. This year approximately 140 persons will receive case management and rental assistance in the form of rental subsidies or short-term rental assistance. The agreement will be monitored by the Department of Planning staff, who will review quarterly reports and annual reports submitted by the City of Yonkers.

The agreement is exempt from the procedures of the County Procurement Policy pursuant to Section 3(a)iii thereof.

Act # 31-2011 was adopted on March 14, 2011, by the Westchester County Board of Legislators authorizing the County to enter into an Intermunicipal Agreement with the City of New York to accept a Federal grant, for the amount of \$2,156,782.00 for Year Nineteen (Fiscal Year 2010) HOPWA grant funds. On May 5, 2011, the Board of Acquisition and Contract approved a resolution authorizing the County to administer the HOPWA grant.

Act # 30-2011 was adopted on March 14, 2011, by the Westchester County Board of Legislators. The Act authorizes the County of Westchester to enter into an Intermunicipal Agreement with the City of Yonkers and other municipalities for the purpose of administering the Federal Housing Opportunities for Persons with AIDS (HOPWA) Program with Fiscal Year 2010 funds. The amount of the funds allocated for the City of Yonkers is \$357,000.00 from the Year Nineteen allocation.

I recommend approval of this agreement.

The agreement will provide funding to the City of Yonkers from the Fiscal Year 2010 Federal HOPWA Program for programs and services that will benefit local residents, and be it further
