Re: **Request for Authority to Solicit Bids by Public Advertisement for Six (6) Moving Services Contracts of Voting Machines, Supply Bags and Privacy Booths between the County Warehouse and Various Polling Place Locations for the 2011 Primary Election covering Zones 1 through 6, (BOE 11-07, BOE 11-08, BOE 11-09, BOE 11-10, BOE 11-11 and BOE 11-12, respectively).**

Attached for your consideration is a Resolution which, if approved by your Honorable Board, would authorize the Board of Elections to solicit bids by public advertisement for six (6) moving services contracts for Zones 1 through 6, respectively, between the County Warehouse and various polling place locations in the County of Westchester (the "County") of voting machines, supply bags and privacy booths for the 2011 Primary Election, (BOE 11-07, BOE 11-08, BOE 11-09, BOE 11-10, BOE 11-11 and BOE 11-12 respectively). These six (6) contracts will commence on September 1, 2011 and terminate on September 31, 2011. The Primary Election moving services contracts are being bid separately from the General Election moving services contracts since not all of the voting districts within the County will hold primaries. Since the final number of the voting districts that are holding primaries have not yet been determined, the County will receive a pro-rata credit based upon the number of polling places in each Zone that are ultimately used in the Primary Election. The public purpose, as well as the goal and objective of this contract, is to allow the Board of Elections to carry out its statutory duties in connection with the upcoming 2011 Primary Election and to ensure that all eligible County residents have the opportunity to exercise their right to vote.

The six (6) contracts shall be for the following geographic zones:

Contract No. BOE 11-07 - 2011 Primary Election Moving Services of Voting Machines, Supply Bags and Privacy Booths between the County Warehouse and Various Polling Place Locations in Westchester County Zone 1 - Cortlandt, Ossining, Peekskill, Somers and Yorktown;

Contract No. BOE 11-08 - 2011 Primary Election Moving Services of Voting Machines, Supply Bags and Privacy Booths between the County Warehouse and Various Polling Place Locations in Westchester County Zone 2 - Bedford, Lewisboro, Mount Kisco, New Castle, North Salem and Pound Ridge;

Contract No. BOE 11-09 - 2011 Primary Election Moving Services of Voting Machines, Supply Bags and Privacy Booths between the County Warehouse and Various Polling Place Locations in Westchester County Zone 3 - Greenburgh, Harrison, Mount Pleasant, North Castle and White Plains;

Contract No. BOE 11-10 - 2011 Primary Election Moving Services of Voting Machines, Supply Bags and Privacy Booths between the County Warehouse and Various Polling Place Locations in Westchester County Zone 4 - Mamaroneck, New Rochelle, Rye Town and Rye City;

Contract No. BOE 11-11 - 2011 Primary Election Moving Services of Voting Machines, Supply Bags and Privacy Booths between the County Warehouse and Various Polling Place Locations in Westchester County Zone 5 - Eastchester, Pelham, Mount Vernon, Scarsdale;

and

Contract No. BOE 11-12 - 2011 Primary Election Moving Services of Voting Machines, Supply Bags and Privacy Booths between the County Warehouse and Various Polling Place Locations in Westchester County Zone 6 - Yonkers.

Pursuant to applicable law, the County is required to store, transport and secure voting machine equipment in connection with all Primary and General Elections. Due to the large numbers of voting machines, supply bags and privacy booths that must be transported to and from polling place locations, this service is best handled through an outside vendor as the County does not have sufficient staff to carry out this work. By having such a contract in place, the County will be able to carry out its statutory duties in connection with the upcoming 2011 Elections.

The performance of the successful bidder under this contract will be monitored by the staff of the Board of Elections to ensure compliance with contract terms. If this contract is not approved, the County would be in violation of its statutory duties and it would prevent County residents from exercising their right to vote.

Approval of the attached resolution is respectfully requested.

CONTRACT NO. BOE 11-10 - 2011 PRIMARY ELECTION MOVING SERVICES OF VOTING MACHINES, SUPPLY BAGS AND PRIVACY BOOTHS BETWEEN THE COUNTY WAREHOUSE AND VARIOUS POLLING PLACE LOCATIONS IN WESTCHESTER COUNTY ZONE 4 - MAMARONECK, NEW ROCHELLE, RYE TOWN AND RYE CITY;

CONTRACT NO. BOE 11-11 - 2011 PRIMARY ELECTION MOVING SERVICES OF VOTING MACHINES, SUPPLY BAGS AND PRIVACY BOOTHS BETWEEN THE COUNTY WAREHOUSE AND VARIOUS POLLING PLACE LOCATIONS IN WESTCHESTER COUNTY ZONE 5 - EASTCHESTER, PELHAM, MOUNT VERNON, SCARSDALE;
