On July 20, 2011, ten (10) bids were received and opened for Contract No. 10-518 for Roadway Resurfacing and Related Improvements, North Street (C.R. No. 30), From Westchester Avenue to Hutchinson River Parkway, City of White Plains, New York.

The bids were reviewed by the Department and it was determined that Petrillo Contracting, Inc. submitted the low bid in the amount of \$2,620,000.00.

The low bidder has been investigated and it has been found that Petrillo Contracting, Inc.:

- Performed satisfactory work in the past for the County.
 Past experience has been investigated and found satisfactory.

The objective of this contract is to replace substandard areas of asphalt paving, thus addressing the County Executive's priority area: Safety and Security (SS).

This contract is in the public's best interest because it will promote the health and safety of the general public by ensuring that North Street meets current codes and standards as well as reducing the County's annual maintenance costs.

The project will provide an environmental benefit by eliminating flooding conditions due to damaged drainage structures.

The department will track scheduling and accomplishments by the contractor and perform on-site inspections to ensure the successful completion of this project.

It is my recommendation that Contract No. 10-518 be awarded to Petrillo Contracting, Inc. in the amount of \$2,620,000.00.

Payment for a portion of this contract will be made from the Federal Transit Administration Funds, not the County General Fund and will not impact the County tax levy.
