On August 17, 2011, one (1) bid was received and opened for Contract No. BOE 11-18 - 2011 General Election Moving Services of Voting Machines, Supply Bags and Privacy Booths between the County Warehouse and Various Polling Place Locations in Westchester County Zone 6 - Yonkers.

The bid was reviewed and it was determined that Ron's Trucking Corporation submitted the sole bid in the amount of \$39,000.00.

The sole bidder has been investigated and it has been found that Ron's Trucking Corporation:

- Performed satisfactory work in the past for the County.

The objective of this contract is to transport voting machine equipment in connection with the General Election, so that the County will be able to carry out its statutory duties in connection with the upcoming 2011 Elections.

# RESOLUTION

## CONTRACT NO. BOE 11-18

Upon communication from the Commissioner of Public Works and Transportation, be it

**RESOLVED**, that Contract No. BOE 11-18 - 2011 General Election Moving Services of Voting Machines, Supply Bags and Privacy Booths between the County Warehouse and Various Polling Place Locations in Westchester County Zone 6 – Yonkers, be and is hereby awarded to the sole bidder, Ron’s Trucking Corporation, 2 Locust Hill Avenue, Yonkers, NY 10701, in the amount of \$39,000.00; and be it further

**RESOLVED**, that this contract is subject to County appropriations; and be it further

**RESOLVED**, that this Agreement is also subject to further financial analysis of the impact of any New York State Budget (the “State Budget”) proposed and adopted during the term of this Agreement. The County shall retain the right, upon the occurrence of any release by the Governor of a proposed State Budget and/or the adoption of a State Budget or any amendments thereto, and for a reasonable period of time after such release(s) or adoption(s), to conduct an analysis of the impacts of any such State Budget on County finances. After such analysis, the County shall retain the right to either terminate this Agreement or to renegotiate the amounts and rates approved herein. If the County subsequently offers to pay a reduced amount to the Contractor, then the Contractor shall have the right to terminate this Agreement upon reasonable prior written notice; and be it further

**RESOLVED**, that the County Executive or his authorized designee is hereby authorized and empowered to execute any and all documents necessary or appropriate to effectuate the purposes hereof.
