On July 27, 2011, eight (08) bids were received and opened for Contract No. 11-210 for River Bank Stabilization, Bronx River South Of Popham Road, Village Of Scarsdale, New York.

The bids were reviewed by the Department and it was determined that Arabia Contracting Inc. **(WBE)** submitted the low bid in the amount of \$102,120.00.

The low bidder has been investigated and it has been found that Arabia Contracting Inc. **(WBE)**:

- Performed satisfactory work in the past for the County.
 Past experience has been investigated and found satisfactory.

The objective of this contract is to stabilize a portion of the river bank located along the Bronx River in Scarsdale.

This contract is in the public's best interest because it will provide an environmental benefit by reducing flooding and erosion, thus addressing the County Executive's priority area: Health and the Environment (HE).

The department will track scheduling and accomplishments by the contractor and perform on-site inspections to ensure the successful completion of this project.

It is my recommendation that Contract No. 11-210 be awarded to Arabia Contracting Inc. **(WBE)** in the amount of \$102,120.00.

Payment for this entire contract will be made from the United States Department of Agriculture – Natural Resources Conservation Service Grant, not the County General Fund and will not impact the County tax levy.
