On September 14, 2011, eight (08) bids were received and opened for Contract No. 11-543 for Rehabilitation of North Street Bridge (BIN 3348230) Over Playland Parkway, City of Rye, New York.

The bids were reviewed by the Department and it was determined that McNamee Construction Corp. submitted the low bid in the amount of \$874,425.00.

The low bidder has been investigated and it has been found that McNamee Construction Corp.:

- Performed satisfactory work in the past for the County.
 Past experience has been investigated and found satisfactory.

The objective of this contract is to repair substandard structural elements of the North Street Bridge, thus addressing the County Executive's priority area: Safety and Security (SS).

This contract is in the public's best interest because it will promote the health and safety of the general public by ensuring that the North Street Bridge meets current codes and standards as well as reducing the County's annual maintenance costs. There are no energy or environmental components associated with this project.

The department will track scheduling and accomplishments by the contractor and perform on-site inspections to ensure the successful completion of this project.

It is my recommendation that Contract No. 11-543 be awarded to McNamee Construction Corp. in the amount of \$874,425.00.
