RE: AUTHORIZATION TO AMEND THE LICENSE AGREEMENT (IT-1007) WITH SPRINT SPECTRUM L.P., FOR THE OPERATION OF RADIO EQUIPMENT AT THE PUBLIC SAFETY RADIO TOWER IN HAWTHORNE, TO EXTEND THE TERMINATION DATE TO MAY 31, 2012

BACKGROUND:

- By resolution approved December 23, 2008, Westchester County ("the County") entered into a license agreement with Sprint Spectrum, L.P. ("Sprint") whereby the County agreed to the operation of certain equipment and antennas at the County's Public Safety Radio Tower in Hawthorne, New York.
- Sprint wishes to continue its operation at this site and the County agrees to an extension of the termination date of the license agreement.
- This amendment will extend the operation of the existing equipment and antennas by Sprint at the Public Safety Radio Tower to May 31, 2012. No new equipment or antennas will be installed as a result of this amendment.
- All other terms and conditions of the original license agreement (IT-1007) will remain the same.
- This procurement is exempt from the Westchester County Procurement Policy pursuant to section 3(b). "This policy shall not apply to real property leases, licenses, and concessions."

ACTION REQUESTED:

- Authorization to amend the license agreement (IT-1007) with Sprint Spectrum L.P., having a place of business located at 6391 Sprint Parkway, Mailstop KSOPHT0101-Z2650, Overland Park, Kansas 66251, for the operation of radio equipment at the Public Safety Radio Tower in Hawthorne, to extend the termination date of the agreement to May 31, 2012, and increase the revenue amount by \$10,877.91, with all other terms and conditions of the agreement remaining the same.

Accordingly, the attached resolution is submitted for your consideration.

RESOLVED, that the County Executive or his duly authorized designee is hereby authorized to execute and deliver any and all documents and to take all action necessary and appropriate to effectuate the purposes hereof.
