order to change the expiration date

On March 4, 2010, your Honorable Board approved a resolution to enter into an agreement with Housing Action Council. Inc. to provide professional services to assist with the implementation of the Federal Neighborhood Stabilization Program (NSP) by counseling households interested in purchasing foreclosed properties. The term of the agreement is March 1, 2010 to February 28, 2012 with the option to renew said agreement for one (1) or two (2) year(s) period with the same prices, terms and conditions based on the success of the program. The amount of the grant is \$105,000.00 to be paid pursuant to an approved budget.

The attached resolution authorizes the County of Westchester to amend the agreement with Housing Action Council, Inc. to change the contract expiration date from February 28, 2012 to February 28, 2014. All other terms and conditions of the agreement will remain the same.

Housing Action Council, Inc. has requested an amendment as additional time is necessary in order to provide home buying education and follow-up financial counseling to the new homeowners of the NSP properties. Most of these properties are still in the rehabilitation phase and potential buyers have not been identified.

The goal and objective of the original agreement is to provide assistance in the furtherance of providing fair and affordable housing in Westchester County. The project will be monitored by the Planning Department staff who will have regular meetings with HAC and will review the documents to insure all contractual obligations are met.
