On February 8, 2012, three (03) bids were received and opened for Contract No. 08-534 for Emergency Generator Replacement, Yonkers Joint Wastewater Treatment Plant, Yonkers, New York.

The bids were reviewed by the Department and it was determined that Verde Electric Corp. submitted the low bid in the amount of \$4,828,000.00, and has proposed the utilization of the following subcontractor: Southeast Mechanical Corp. (HVAC Work), 568 North Main Street, Brewster, New York 10509.

The low bidder has been investigated and it has been found that Verde Electric Corp.:

- Performed satisfactory work in the past for the County.
 Past experience has been investigated and found satisfactory.

The objective of this contract is to allow the Department of Environmental Facilities to maintain its treatment plant systems and to ensure continuous and reliable processing of wastewater during a power outage.

This contract is in the public's best interest because it will promote the health and safety of the general public by ensuring continued uninterrupted operation of the plant's wastewater treatment systems. This project will enable the Department of Environmental Facilities to carry out its basic mission to provide wastewater treatment and maintain satisfactory water quality, thus addressing the County Executive's priority area: Health and the Environment (HE).

The department will track scheduling and accomplishments by the contractor and perform on-site inspections to ensure the successful completion of this project.

It is my recommendation that Contract No. 08-534 be awarded to Verde Electric Corp. in the amount of \$4,828,000.00.
