Re: **Authorization to extend a contract with Securitas Security Services USA, Inc. (No. WCC-09-709) to provide uniformed security services for Westchester Community College for the period January 1, 2012 through December 31, 2012, for an amount not to exceed \$1,846,958**

---

By a Resolution approved on November 19, 2009, your Honorable Board awarded a contract for the provision of uniformed security services for Westchester Community College (the "College") to the lowest bidder, Securitas Security Services, USA, Inc. ("Securitas") for the period January 1, 2010 through December 31, 2010, with the County's option to extend the contract for four (4) additional one-year periods. By a resolution approved on March 10, 2011, the County exercised its first option to extend the contract for the year 2011. As Securitas provided satisfactory services through 2011, the College recommends that the County exercise its second option to extend the contract for an additional year (January 1, 2012 – December 31, 2012) in the amount not-to-exceed \$1,846,958. This amount includes a wage rate adjustment in accordance with the terms of the original contract. The goal and objective of this contract is to protect the safety of students and staff and property by providing security services for the College. The performance of Securitas will be continually monitored by College staff to ensure that contractual obligations are met by Securitas.

Approval of the attached resolution is respectfully recommended.

## RESOLUTION

Upon a communication from Dr. Joseph N. Hankin, President, Westchester Community College, be it hereby

**RESOLVED**, that contract no. WCC-09-709 for uniformed security services with Securitas Security Services USA, Inc. for Westchester Community College is hereby extended for the period January 1, 2012 through December 31, 2012, with the County's option to extend the contract for two (2) additional one-year periods, with a not to exceed amount of \$1,846,958 payable at the adjusted rates in accordance with the contract provisions for the second option year; and be it further

**RESOLVED**, that this Agreement is subject to County appropriations; and be it further

**RESOLVED**, that this Agreement is also subject to further financial analysis of the impact of any New York State Budget (the "State Budget") proposed and adopted during the term of this Agreement. The County shall retain the right, upon the occurrence of any release by the Governor of a proposed State Budget and/or the adoption of a State Budget or any amendments thereto, and for a reasonable period of time after such release(s) or adoption(s), to conduct an analysis of the impacts of any such State Budget on County finances. After such analysis, the County shall retain the right to either terminate this contract or to renegotiate the amount and rates approved herein. If the County subsequently offers to pay a reduced amount, then the Contractor shall have the right to terminate this Agreement upon reasonable prior written notice; and be it further

**RESOLVED**, that the County Executive or his authorized designee is hereby authorized to execute the above agreements on behalf of the County of Westchester.
