The Contract was subsequently executed.

Contract completion was delayed due to field conditions and construction issues. Therefore, the County now seeks authority from your Honorable Board to amend the July 10, 2008 Resolution budget box end date from July 14, 2011 to December 31, 2012.

All other terms and conditions of the July 10, 2008 Resolution and the Contract shall remain in full force and effect and unchanged.
