By Resolution approved on July 24, 2008 your Honorable Board awarded Contract No. 07-502-GC for Primary Digester Roof Replacement, Yonkers Joint Wastewater Treatment Plant, Yonkers, New York to Spectraserv Inc. in the amount of \$3,821,500.00, for the period August 7, 2008 through August 8, 2011. The Contract was subsequently executed.

Contract completion was delayed due to field conditions and construction issues. Therefore, the County now seeks authority from your Honorable Board to amend the July 24, 2008 Resolution budget box end date from August 8, 2011 to September 30, 2012.

All other terms and conditions of the July 24, 2008 Resolution and the Contract shall remain in full force and effect and unchanged.
