By Resolution approved on November 5, 2009 your Honorable Board awarded Contract No. 08-511 for Resurfacing And Related Improvements, New York Post Road (C.R. 53) From Scarsdale/White Plains Line To Mamaroneck Avenue, A Distance Of 1.25 Miles, City of White Plains, New York to Montesano Brothers, Inc. in the amount of \$1,171,487.00, for the period November 19, 2009 through July 18, 2011. The Contract was subsequently executed.

Contract completion was delayed due to field conditions and construction issues. Therefore, the County now seeks authority from your Honorable Board to amend the November 5, 2009 Resolution budget box end date from July 18, 2011 to October 31, 2012.

All other terms and conditions of the November 5, 2009 Resolution and the Contract shall remain in full force and effect and unchanged.
