SUBJECT: Authority to Enter into an Agreement with the United States of America, acting by and through the Federal Aviation Administration ("FAA"), to accept a grant for Capital Project Number A054A – Rehabilitation of Various Taxiways at the Westchester County Airport

Authority of your Honorable Board is requested for the County of Westchester, acting by and through the Department of Public Works and Transportation, to enter into an Agreement with the United States of America, acting by and through the FAA, to accept a grant of approximately \$540,000.00 for Capital Project Number A054A – Rehabilitation of Various Taxiways at the Westchester County Airport. This grant will be used to fund design of the rehabilitation of Taxiway "A" in two areas – (1) between Runway 11/29 and Taxiway "G"; and (2) between Taxiway "E" and the Runway 16 threshold, including intersection work at Taxiways "B", "C", "D", and "E" and all associated markings, lighting, signage and drainage for the southern and northern sections of Taxiway "A".

It shall be noted that on July 9, 2012 the Board of Legislators approved Act 88-2012, which amended Act 206-2011, authorizing the County to enter into a grant agreement with the FAA to accept funds for Capital Project Number A054A. The County will have to contribute a local share of approximately \$60,000.00 from the Airport Special Revenue Fund.

This Agreement will serve a public purpose by funding improvements to Taxiway "A" that will ensure continued compliance with safety, security, and environmental goals and objectives.

The objective of this Agreement is to accept federal funding for a capital project that directly improves the safety, security and environmental protection of County residents and Airport users. This is a project the County and its Airport would be responsible to fund directly were it not for the availability of federal grant funds. Acceptance of these funds will relieve the County and the Airport of substantial fiscal responsibility.

The County's Department of Public Works and Transportation will monitor and report the progress of this project using its own staff and staff from other County departments as appropriate, and will be responsible to invoice the FAA for timely reimbursement as the costs are incurred.

I certify that my department, a) has copies of, or access to, all applicable laws, rules, regulations, grant applications, and grant agreements (including any master grant agreement), as well as any guidance or instructions received from the agency making the grant (the "Grant Terms"), b) has reviewed the Grant Terms, c) is aware of and understands all of the Grant Terms, and d) can and will comply with all of the Grant Terms.

Accordingly, I recommend your Honorable Board's approval of the annexed Resolution authorizing the County to enter into this grant agreement with the FAA.

RESOLUTION

Upon communication from the Commissioner of Public Works and Transportation, be it:

RESOLVED, that the County of Westchester, acting by and through the Department of Public Works and Transportation, is hereby authorized to enter into an agreement with the United States of America, acting by and through the Federal Aviation Administration ("FAA"), to accept a grant of approximately \$540,000.00 for Capital Project Number A054A – Rehabilitation of Various Taxiways at the Westchester County Airport. This grant will be used to fund design of the rehabilitation of Taxiway "A" in two areas – (1) between Runway 11/29 and Taxiway "G"; and (2) between Taxiway "E" and the Runway 16 threshold, including intersection work at Taxiways "B", "C", "D", and "E" and all associated markings, lighting, signage and drainage for the southern and northern sections of Taxiway "A"; and be it further

RESOLVED, that the Agreement will provide, among other things, that the County will contribute a local share of approximately \$60,000.00 toward the cost of Capital Project Number A054A – Rehabilitation of Various Taxiways at the Westchester County Airport, which funding will come from the Airport Special Revenue Fund; and be it further

RESOLVED, that the County Executive or his duly authorized designee is hereby authorized and empowered to execute any and all documents necessary or appropriate to effectuate the purposes hereof.
