Authority to amend an agreement with The Council of State Governments/American Re:

Probation and Parole Association ("CSG/APPA") pursuant to which the County. through its Department of Probation, agreed to participate in a Development of Risk Assessment Tools, Curriculum, and Training for Driving While Impaired ("DWI") Supervision project for a term commencing July 1, 2011 and continuing through June 30, 2012, for an amount not-to-exceed \$7,500, by extending the term of the agreement

On or about July 01, 2011 the County entered into a "short-form" contract with CSG/APPA pursuant to which the County, through its Department of Probation (the "Department"), agreed to participate in a Development of Risk Assessment Tools, Curriculum, and Training for DWI Supervision project for a term commencing July 1, 2011 and continuing through June 30, 2012 (the "Agreement"). In consideration for its participation in the project, CSG/APPA agreed to pay the County an amount not-to-exceed \$7,500. The Agreement was subsequently executed.

The parties now desire to amend the agreement in order to 1) extend the term thereof for one (1) additional year, from July 1, 2012 through June 30, 2013; and 2) increase the total not-to-exceed amount by an additional \$2,500, from an amount not-to-exceed \$7,500, to an amount not-to-exceed \$10,000, to compensate the County for its continued participation in this project.

As your Honorable Board is aware, amendments to short-form contracts which result in increases that exceed the \$20,000.00 monetary threshold or exceed the one (1) year term limitation for short-form contracts, must first be approved by your Honorable Board. Since the term of the Agreement, as amended, will exceed the one year term limitation, the approval of your Honorable Board is now required. Accordingly, authority is respectfully requested to amend the Agreement with CSG/APPA by 1) extending the term thereof for one (1) additional year, from July 1, 2012 through June 30, 2013; and 2) increasing the total not-to-exceed amount by an additional \$2,500, from an amount not-to-exceed \$7,500, to an amount not-to-exceed \$10,000, to compensate the County for its continued participation in this project.

Except as specifically amended hereby, all other terms and conditions of the Agreement shall remain in full force and effect.

This project will further efforts to address the issue of impaired driving and, more specifically, offenders who are under community supervision for DWI offenses, by developing an offense-specific risk assessment tool to assist in the supervision of DWI offenders and training for community supervision officers on how to effectively supervise this population.

This Agreement will serve a public purpose by helping the Department to better supervise DWI offenders thereby reducing the incidence of recidivism.

The goals and objectives of this Agreement are to create a risk assessment instrument specifically for DWI offenders.

The goals and objectives are in the best interest of the County in terms of public health and safety because the risk assessment tool developed through this study will reduce the recidivism rate for DWI offenders thus making our roads safer.

This project will be tracked and monitored by the Department and by CSG/APPA.

Accordingly, your favorable action on the annexed Resolution is most respectfully urged and recommended.
