On August 15, 2012, eleven (11) bids were received and opened for Contract No. 07-527 for Consolidation of Permitted Outfalls #8, #9 and #10, Westchester County Airport, Towns of Harrison and North Castle and Village of Rye Brook, New York.

The bids were reviewed by the Department and it was determined that Morano Brothers Corp. submitted the low bid in the amount of \$325, 190.00.

The low bidder has been investigated and it has been found that Morano Brothers Corp.:

The objective of this contract is to redirect stormwater flow from outfalls #8 and #9 to outfall #10.

This contract is in the public's best interest because it will promote the health and safety of the general public by complying with the New York State Department of Environmental Conservation's permitting requirements for these stormwater outfalls, thus addressing the County Executive's priority area: Health and the Environment (HE).

The department will track scheduling and accomplishments by the contractor and perform on-site inspections to ensure the successful completion of this project.

Payment for this entire contract will be made from the Airport Special Revenue Fund, not the County General Fund and will not impact the County tax levy.

It is my recommendation that Contract No. 07-527 be awarded to Morano Brothers Corp. in the amount of \$325,190.00.
