Re: Resolution to exempt from the Westchester County Procurement Policy an Agreement with Program Design and Development, LLC for the provision of professional consulting services related to the County's application to the United States Department of Housing and Urban Development ("HUD") for 2013 Continuum of Care for the Homeless grant, pursuant to Section 3(a) xxi thereof

Authority is hereby requested from your Honorable Board to exempt from the Westchester County Procurement Policy and Procedures an agreement with Program Design and Development, LLC for the provision of professional consulting services for the preparation of the County's fiscal year 2013 application to the United States Department of Housing and Urban Development ("HUD") for Continuum of Care for the Homeless grant and related services for the term January 1, 2013 through December 31, 2013 in the amount of \$42,000 payable pursuant to an approved budget.

This agreement will provide consulting services to the Department of Social Services which will enable the County to obtain needed HUD funding. Program Design and Development, LLC has been involved in planning and administering HUD's Continuum of Care grant programs since 1993 and is uniquely qualified to provide these services to the County. Program Design and Development, LLC has also coordinated the local HUD Continuum of Care grants for the Yonkers Housing Authority since 1995 and for the City of Mount Vernon since 1996. Based on Program Design and Development's proven track record and expertise, it would be in the best interests of the County to exempt the proposed agreement from the requirements of Westchester County Procurement Policy and Procedures.

Pursuant to Section 3 (a) (xxi) of the Westchester County Procurement Policy, where this Honorable Board determines by resolution passed prior to the commencement of procurement that compliance with the Policy would not be in the

best interests of the County, the requirements of the Policy may be waived. A resolution to enter into an agreement with Program Design and Development, LLC is being submitted separately with even date.

Your Honorable Board's approval of the annexed resolution is respectfully requested.
