By Resolution approved on July 10, 2008 your Honorable Board awarded Contract No. 06-528-HV for Pump Station Rehabilitation, North Yonkers Pump Station, Yonkers, New York to S & O Construction Services, Inc. in the amount of \$2,405,729.00, for the period from July 24, 2008 through July 14, 2011. The Contract was subsequently executed.

On April 12, 2012, your Honorable Board approved a Resolution to amend the July 10, 2008 Resolution budget box end date from July 14, 2011 to December 31, 2012 due to field conditions and construction issues that delayed contract completion.

Contract completion has been further delayed due to construction issues. Therefore, the County now seeks authority from your Honorable Board to amend the July 10, 2008 Resolution budget box end date from December 31, 2012 to December 31, 2013.

All other terms and conditions of the July 10, 2008 Resolution and the Contract shall remain in full force and effect and unchanged.
