SUBJECT: Resolution authorizing the County of Westchester to enter into a grant agreement with the State of New York to accept funding in connection with the Submission of HAVA Operations Expenses by Board of Elections ("SHOEBOX") Grant Program, in the amount of \$6,022.50

Transmitted herewith is a resolution requesting authority for the County of Westchester (the "County"), acting by and through its Board of Elections ("BOE") to enter into a grant agreement with the State of New York to accept funding in connection with the Submission of HAVA Operations Expenses by Board of Elections ("SHOEBOX") Grant Program in the amount of \$6,022.50, with a grant agreement term of April 1, 2004 through March 31, 2014. These funds are being made available in connection with the 2002 Help America Vote Act ("HAVA"), to be used by the County BOE for reimbursement for any eligible HAVA expenses incurred by the County during the term of the agreement.

The public purpose of this agreement is to accept grant funds to secure reimbursement for HAVA eligible items and thereby assisting in the County's HAVA compliance and furthering voting accessibility for persons with disabilities. Utilizing grant funding will alleviate the need for the use of County tax dollars for this purpose.

We certify that the BOE: a) has copies of, or access to, all applicable laws, rules, regulations, grant applications and grant agreements (including any master grant agreement), as well as any guidance or instructions received from the agency making the grant (the "Grant Terms"), b) has reviewed the Grant Terms, c) is aware of and understands all of the Grant Terms, and d) can and will comply with all of the Grant Terms.
