provision of design services for Westchester Community College publications for

a two (2) year term

Westchester Community College ("WCC") issued a request for proposals seeking design services for Westchester Community College publications for a two (2) year term commencing June 1, 2013 ("RFP"). The RFP asked that each proposer provide an estimated cost for four (4) specific WCC publications along with hourly rates for different publication design services. WCC received four (4) written proposals. Karen Spencer Design, Inc. ("Spencer"), the firm that WCC has worked with for the last six years, submitted a proposal that was slightly more expensive than 2 of the other proposers but that was still competitive in nature. Additionally, they have a proven track record of excellence in their previous six years of providing services to WCC. Based on WCC's past experience with Spencer and the positive feedback received from multiple sources, I recommend continuing WCC's relationship with this vendor.

The proposed agreement would commence on or about June 1, 2013 and continue for two (2) years, payable pursuant to the hourly rates contained in Schedule "A". The total amount payable to Spencer shall not exceed \$60,000 annually for a total amount not to exceed \$120,000.

The public purpose of this agreement is to provide design services for WCC's numerous publications. The value of entering into this agreement will be tracked based on feedback received from WCC's Marketing Committee and Board of Trustees.
