Authority is respectfully requested from your Honorable Board for the County of Westchester, acting by and through its Department of Social Services (the “Department”), (the “County”) to enter into an agreement with the United States Department of Housing and Urban Development (“HUD”) in order to accept a grant in the amount of \$345,652 under HUD’s Continuum of Care Program, to pay for work and services related to the County’s Homeless Management Information System (“HMIS”), for the period from February 1, 2013 through January 31, 2014.

The goals and objectives of the proposed agreement are to provide the funds necessary for the County to pay for work and services related to the County's HMIS.

The goals and objectives of the proposed agreement are in the best interests of the County in terms of fiscal responsibility, as the proposed agreement will make available to the County the funds necessary for the County to pay for work and services related to the County's HMIS. The goals and objectives of the proposed agreement are also in the best interests of the County in terms of public health and safety, as the County's HMIS, which will be funded by the proposed agreement, is designed to track and monitor the placement and status of the homeless clients of the Department and thereby better serve them.

The goals and objectives of the proposed agreement will be tracked and monitored by the Department, in accordance with the requirements of HUD. The Department will be required to prepare and submit an Annual Performance Report to HUD as a requirement of receiving the funding to be provided under the proposed agreement.

The proposed agreement does not constitute procurement. Accordingly, the provisions of the Westchester County Procurement Policy do not apply.

I respectfully recommend your Honorable Board's approval of the attached Resolution.
