RE: **RESOLUTION AUTHORIZING THE COUNTY OF WESTCHESTER TO ENTER INTO AN AGREEMENT WITH THE STATE OF NEW YORK, ACTING BY AND THROUGH THE NEW YORK STATE DIVISION OF CRIMINAL JUSTICE SERVICES TO ACCEPT A GRANT IN AN AMOUNT NOT TO EXCEED \$554,800 IN STATE FUNDS TO OPERATE THE "OPERATION IMPACT" PROGRAM FOR THE PROGRAM PERIOD JULY 1, 2013 THROUGH JUNE 30, 2014, PURSUANT TO AN APPROVED BUDGET**

Authority is sought for the County of Westchester, acting by and through the Office of the District Attorney, to enter into an agreement with the State of New York, acting by and through the New York State Division of Criminal Justice Services ("DCJS"), to accept a grant in an amount not-to-exceed of \$554,800 in State Funds to operate the "Operation IMPACT" (Integrated Municipal Police Anti-Crime Teams) Program (the "Program") for the program period July 1, 2013 through June 30, 2014, pursuant to an approved budget (the "Agreement"). Pursuant to the terms of the Agreement, the County will be required to contribute \$374,626 in County matching funds toward the cost of the Program

The Operation IMPACT Program will promote the health, safety and welfare of the citizens of Westchester County by using a collaborative effort amongst a number of law enforcement agencies. The goal of the Program is to reduce gun violence and enhance the utilization of intelligence and crime analysis in local crime fighting strategies to help reduce crime in the County and thereby make the County safer. The goals and objectives of the Program will be monitored by the District Attorney's Office and quarterly reports will be submitted to DCJS for their review approval.
