Re: Resolution authorizing the County of Westchester to amend an Intermunicipal Agreement with the City of New Rochelle for Round Trip Prisoner Transportation between New Rochelle and the Westchester County Jail for the term commencing January 1, 2012 and terminating December 31, 2013 in the total amount not to exceed \$468,061 in order to increase the contract amount by \$58,516 to a new total amount not to exceed \$526,577

On September 3, 2013, the Westchester County Board of Legislators adopted Act Number 157-2013 authorizing the County to amend an intermunicipal agreement with the City of New Rochelle ("New Rochelle") for the term commencing January 1, 2012 through December 31, 2013, whereby New Rochelle will provide round trip transportation for prisoners between New Rochelle and the Westchester County Jail in Valhalla, New York, (the "Agreement") in order to increase the amount of the Agreement from \$468,061 to \$526,577.

The proposed amendment is necessary as the result of a delay in receiving the final 2012 bills from New Rochelle which reflected the actual prisoner transports that New Rochelle made in 2012 and is expected to make in 2013. The reimbursement rates to New Rochelle for round trip transportation pursuant to the Agreement will remain unchanged for the 2012-13 period. All other terms and conditions of the original agreement shall remain in full force and effect.

The public purpose of the proposed amendment agreement is for the County to carry out its duty to transport arraigned prisoners between local courts and the County Jail in order to make mandatory court appearances in a cost effective manner. The goal of maintaining the safety of the public and prisoners while prisoners are transported to and from the County Jail was tracked and monitored by the Department of Correction through booking records and monthly invoices. This agreement is exempt from procurement pursuant to §3(a)(iii) of the County Procurement Policy.

A resolution for your consideration is annexed hereto which I recommend for your favorable consideration.
