By Resolution approved on December 1, 2011 your Honorable Board awarded Contract No. 11-511 for New Rochelle Reservoir No. 3 Dam Rehabilitation, NYS DEC I.D. No. 215-1336, Town of Eastchester and City of New Rochelle, New York to ELQ Industries, Inc. in the amount of \$2,769,726.00, for the period December 15, 2011 through September 14, 2013. The Contract was subsequently executed.

Contract completion was delayed due to the postponement of the extensive tree plantings and establishment of the reservoir bank vegetation. This type of work cannot take place during cold weather conditions and had to be delayed a season until more favorable temperatures and conditions returned. Therefore, the County now seeks authority from your Honorable Board to amend the December 1, 2011 Resolution budget box end date from September 14, 2013 to September 14, 2014.

All other terms and conditions of the December 1, 2011 Resolution and the Contract shall remain in full force and effect and unchanged.
