By Resolution approved on November 24, 2009 your Honorable Board awarded Contract No. 08-531 for Shaft 22 Facility Improvements, Water District No. 1, Yonkers, New York to Arben Group LLC in the amount of \$474,890.00, for the period December 10, 2009 through September 9, 2011. The Contract was subsequently executed.

On March 22, 2012, your Honorable Board approved a Resolution to amend the November 24, 2009 Resolution budget box end date from September 9, 2011 to December 31, 2013 due to permitting issues that delayed contract completion.

Contract completion has been further delayed due to construction issues. Therefore, the County now seeks authority from your Honorable Board to amend the November 24, 2009 Resolution budget box end date from December 31, 2013 to December 31, 2014.

All other terms and conditions of the November 24, 2009 Resolution and the Contract shall remain in full force and effect and unchanged.
