Re: Authorization to enter into Contract with Columbia University to accept funding for the

Evaluation of Public Health Systems Response to Hurricane Sandy in the NYC Area Program

Grant, pursuant to an approved budget, as follows:

Contract Period: 2/20/14 – 9/29/15

Contract Amount: Not-To-Exceed \$17,500

The Westchester County Department of Health (the "WCDH") seeks authorization to enter into contract with Columbia University to accept funding for the Evaluation of Public Health Systems Response to Hurricane Sandy in the NYC Area Program Grant, for the contract period 2/20/14 through 9/29/15, pursuant to an approved budget, in the amount not-to-exceed \$17,500.

This Program will promote the public health, safety and general welfare of County residents by improving the response protocol to a large scale disaster event through identification of critical processes, policies, and procedural strategies that will enable the County to respond more efficiently and effectively to such public health emergencies.

The goal is to examine how the response and recovery to the Hurricane Sandy devastation could be enhanced through science and research in order to aid in the long-term recovery from natural disasters. This research program will provide scientific evidence-based applications to public health preparedness, response, and recovery practice.

Program objectives include the evaluation of the processes, policies, procedures and decision making activities prior, during and following Hurricane Sandy over a two year period. This will be accomplished in two steps; there will be scheduled interviews with WCDH senior staff as well as focus groups of line staff, and the majority of the interviews will take place during the first year of the study as well as data analysis at the National Center for Disaster Preparedness at Columbia University. There will be a series of trainings at the WCDH during the second year of this grant.

Program outcomes and findings will be presented at the Public Health Summit to share and address lessons learned and best practices regarding the administrative issues affecting public health response to disasters.
