Westchester and Westchester Residential Opportunities, Inc., for Fair Housing Education and Asset Building Programs in order to increase the dollar amount

On March 20, 2014, your Honorable Board authorized the County of Westchester to enter into an agreement with Westchester Residential Opportunities, Inc., for a program to provide Fair Housing Education and Asset Building /Individual Development Account programs in Westchester County. The amount of the agreement shall not exceed \$30,000.00, pursuant to an approved budget, and the term of the agreement is January 1, 2014 to December 31, 2014.

The attached resolution authorizes the County of Westchester to amend the above referenced agreement in order to increase the dollar amount from \$30,000.00 to \$31,600.00, an increase of \$1,600.00. The additional funds will be used to pay facility rental expenses related to the Westchester Fair and Affordable Housing Expo held at the Westchester County Center.

The goal of the original agreement is to help fulfill the County's housing goals. The program will be monitored by Department of Planning staff, who will review all payment requests to make sure all contractual requirements are met.

I recommend approval of this amendment.
