The 2014 Operating Budget contains funds for the above referenced project.

The work under this contract consists of furnishing labor and equipment for hauling of yard waste and disposal of yardwaste at commercial composting facilities.

This contract is for a term of three (3) years, with two (2) one (1) year renewals by mutual consent of both the County of Westchester and the contractor with all pricing, terms and conditions remaining the same as provided for in the original contract document.

The objective and/or goal of this contract is to provide yard waste hauling services for Westchester County's municipalities. This contract is deemed to fulfill a public purpose as the services provided under this contract promote the public health and welfare by insuring proper transfer of municipally collected yard waste to commercial composting facilities. The contract enables the Department to carry out its basic mission to provide proper solid waste stream recycling to protect the health, safety and welfare of the public.

Tracking will be accomplished by the collection and documenting of weigh scale tickets provided for each load of Organic Yard Waste collected and transported by the contractor under this Contract.
