RE: AUTHORIZATION FOR THE COUNTY TO AMEND CONTRACT IT-1199 WITH COMCAST BUSINESS SERVICES IN ORDER TO EXTEND THE CONTRACT FOR HIGH SPEED INTERNET SERVICES FOR AN ADDITIONAL THREE-YEAR TERM COMMENCING JULY 15, 2014 AND TERMINATING JULY 14, 2017 AND INCREASING THE CONTRACT AMOUNT FOR THE EXTENDED THREE YEAR TERM BY \$4,500 FOR A NEW TOTAL NOT TO EXCEED CONTRACT AMOUNT OF \$8,700.

- On June 28, 2011, your Honorable Board approved a resolution which authorized the County to enter into an agreement (IT-1199) with Comcast Business Services ("Comcast") for the provision of high-speed network services for a three year period commencing July 15, 2011 and terminating July 14, 2014 for a total not to exceed contract amount of \$4,200 (the "Agreement").
  - The Department of Social Services is collaborating with the One Stop Employment Center in the Town of Carmel, Putnam County. The Putnam County staff at this facility requires a high-speed network connection in order to effectively communicate with the Westchester County network. Under the IMA between Westchester and Putnam, Westchester County is authorized to be the contracting agent for the Westchester-Putnam Workforce Investment Board.
  - Comcast Business Services ("Comcast") is the sole source provider for high-speed network service in this location. Other vendors cannot provide the required bandwidth at this location to support this project. Pursuant to Section 9 (a) of the Westchester County Procurement Policy and Procedures, it is our recommendation that after reasonable investigation, it has been determined that High-speed Internet service with a bandwidth of 12MB Down/2MB UP service from Comcast is the only one practicable source for these services.
  - Normally cable modem service would be installed as a lower bandwidth option, however the County's current provider does not provide the required network connection to this area. Comcast has the required bandwidth and technical support to provide the stable ISP service required. Therefore, we now come before your Honorable Board requesting authorization to amend the agreement with Comcast for High-speed Internet Service services for a three year period commencing July 15, 2014 for a total not to exceed amount of \$4,500.

- The agreement requested in the attached resolution will have a public purpose because establishing a connection with the One Stop Employment Center in Putnam County will allow for improved resource and information sharing between the Westchester and Putnam offices, providing more employment options for the public thereby improving the general welfare of County residents.
- The goals and objectives for the requested contract are to provide cable-based Internet service, which is an efficient means for communicating at a higher speed, but at lower cost. The service will also be used to conduct Video Conferencing meetings and training sessions for staff which will reduce travel and be more efficient. DoIT will monitor the services provided in the agreement to be sure the service is in proper working order.

**ACTION REQUESTED:**

- Authorization to amend an agreement (IT-1199) with Comcast Business Services, having an office located at 1701 JFK Boulevard Philadelphia, Pennsylvania 19103, for high-speed Internet service with a bandwidth of 12MB Down/2MB UP extending the agreement for a three year period commencing July 15, 2014 and terminating July 14, 2017, and increasing the amount by \$4,500 for a new total not to exceed contract amount of \$8,700, subject to County appropriations.

A resolution authorizing the above agreement is submitted herewith for your approval.

## RESOLUTION

UPON A COMMUNICATION FROM THE CHIEF INFORMATION OFFICER, DEPARTMENT OF INFORMATION TECHNOLOGY AND THE COMMISSIONER, DEPARTMENT OF SOCIAL SERVICES, BE IT HEREBY

RESOLVED: that the County of Westchester, acting on behalf of the Westchester-Putnam Workforce Investment Board, is hereby authorized to amend an agreement (IT-1199) with Comcast Business Services, having an office located at 1701 JFK Boulevard, Philadelphia, Pennsylvania 19103, for high-speed Internet service with a bandwidth of 12MB Down/2MB UP by extending the agreement for a three year period commencing July 15, 2014 and terminating July 14, 2017, and increasing the amount by \$4,500 for a new total not to exceed contract amount of \$8,700, subject to County appropriations; and be it further

RESOLVED, that subject procurement qualifies as a sole source procurement and is exempt from the procedures of the Procurement Policy under Section 9(a) of said Policy; and be it further

RESOLVED, this Agreement is subject to County appropriations; and be it further

RESOLVED, this Agreement is also subject to further financial analysis of the impact of any New York State Budget (the "State Budget") proposed and adopted during the term of this Agreement. The County shall retain the right, upon the occurrence of any release by the Governor of a proposed State Budget and/or the adoption of a State Budget or any amendments thereto, and for a reasonable period of time after such release(s) or adoption(s), to conduct an analysis of the impacts of any such State Budget on County finances. After such analysis, the county shall retain the right to either terminate this Agreement or to renegotiate the amounts and rates approved herein. If the County subsequently offers to pay a reduced amount to the Contractor, then the Contractor shall have the right to terminate this Agreement upon reasonable prior written notice; and be it further

RESOLVED, that the County Executive or his duly authorized designee is hereby authorized and empowered to execute any and all documents necessary to effectuate the purposes hereof.
