RE: Authorization to apply for and enter into a Grant Agreement with the State of New York ("State") as part of the Household Chemical Waste Collection Program for the State DEC 2013 Fiscal Grant Year, pursuant to Chapter 610 of the Laws of 1993

The State, pursuant to Chapter 610 of the Laws of 1993, provides for State assistance to local governments for household hazardous waste collection and disposal programs. The State grants funds up to 50% of the actual and eligible expenses incurred by local governments. While the approval of your Honorable Board is not required by the County Charter to apply for such grants, the State's application procedure requires it.

The public purpose is to receive revenue from the State that will reimburse the County 50% of eligible costs associated with the operation, equipment and supplies related to the collection and proper disposal of household hazardous waste (HHW) received at the County's Household Material Recovery Facility (H-MRF) in Valhalla, thus reducing the burden to the taxpayer. The goal and objective for entering into this contract is to take advantage of an existing state funding program that reimburses local solid waste managers for HHW related program costs. The application covers eligible expenses starting April 1, 2013 through March 31, 2014. Authority is here requested whereby the County would enter into a grant agreement with the State for reimbursement of up to 50% of the actual and eligible expenses incurred by the County for its HHW collection program. All expenses related to this program have been appropriated in the 2013 and 2014 operating budget for the Department of Environmental Facilities.

All expenses sent to the State for reimbursement must include proof of payment, whether by check number or copy of paid receipt. This application must be received by the State DEC by or before October 31, 2014 and the term of the proposed grant will be for expenses incurred April 1, 2013 through March 31, 2014.

RESOLUTION

Based upon a communication from the Commissioner of Environmental Facilities,

WHEREAS, chapter 610 of the Laws of 1993 provides New York State ("State") assistance for local government household hazardous waste collection programs; and

WHEREAS, Westchester County conducts programs related to the collection and proper disposal of household hazardous wastes, and has examined and duly considered Chapter 610 of the Laws of 1993 of the State of New York and deems it to be in the public's best interest and benefit to file an application under these laws; and

WHEREAS, it is necessary that a grant agreement by and between the State of New York, acting through the Department of Environmental Conservation (DEC), and Westchester County, be executed for such State assistance;

NOW, THEREFORE, BE IT RESOLVED by the Westchester County Board of Acquisition and Contract as follows:

RESOLVED, that the County is hereby authorized to apply for and enter into a grant agreement with the State whereby the County will be reimbursed up to 50% of actual and eligible expenses incurred by the County associated with the operation, equipment and supplies needed for the collection and proper disposal of household hazardous waste received at the county's Household Material Recovery Facility(H-MRF) in Valhalla, following submission of an application in the form required by the State of New York and in conformity with Chapter 610 of the Laws of 1993 and rules and regulations promulgated there under, including all understandings and assurances contained in said application; and be it further

RESOLVED, that the County has fully funded all costs associated with the H-MRF operation in 2013 and 2014; and be it further

RESOLVED, that the term of the grant will be April 1, 2013 to March 31, 2014, to cover the state's 2013 fiscal grant year program; and be it further

RESOLVED, that the County Executive or his duly authorized designee, namely the Commissioner of Environmental Facilities, is hereby authorized to execute all instruments necessary to implement this Resolution.
