The 2014 Operating Budget contains funds for the above referenced project.

The work under this contract consists of providing all necessary labor, material and equipment required to respond to any emergency cleanup of hazardous and non-hazardous spills at the Westchester County Airport. This contract is for a term of three (3) years with one two (2) year renewal at the discretion of the County.

The objective of this contract is to have an on-call contractor who can respond to emergency spills at the Airport and contain and clean up those spills in a timely manner.

This contract is in the public's best interest because it will provide a service that will protect the environment, including the nearby watershed, from contamination through a rapid response to spills.

As expenditures are made pursuant to this authorization, detailed records will be kept in the County's on-line financial system. These records will be easily accessible by Finance, Budget and department staff and will be reviewed regularly to ensure that funds are used appropriately.

Payment for this contract will be made from the Airport Special Revenue Fund, not the County General Fund and will not impact the County tax levy.
