On July 30, 2014, two (2) bids were received and opened for Contract No. 13-535 for Sanitary Service Main Replacement, 110 Dr. Martin Luther King, Jr. Boulevard, White Plains, New York.

Two (2) contractors submitted bids for this project. The project was advertised on the Hudson Valley Municipal Purchasing Group ("HVM") website, in addition to the Journal News (Westchester-Putnam Edition), and was viewed by thirty three (33) entities on the HVM website. In addition, e-mails were sent to those thirty three (33) entities and to an additional two hundred ninety six (296) suppliers and contractors.

The bids were reviewed by the Department and it was determined that Abbott & Price, Inc. submitted the low bid in the amount of \$329,795.00, and has proposed the utilization of the following subcontractor: Gruppuso Plumbing Corp. (Plumbing Work), 848 McLean Avenue, Yonkers, New York 10704.

The low bidder has been investigated and it has been found that Abbott & Price, Inc.:

- Performed satisfactory work in the past for the County.
 Past experience has been investigated and found satisfactory.

The objective of this contract is to replace the existing damaged sanitary service main at 110 Dr. Martin Luther King, Jr. Boulevard.

This contract is in the public's best interest because it will promote the health and safety of the general public by ensuring the continued reliability of plumbing systems along with reducing the County's annual maintenance costs.

This project will provide an environmental benefit by preventing future sanitary spills, thus addressing the County Executive's priority area: Health and the Environment (HE).

The department will track scheduling and accomplishments by the contractor and perform on-site inspections to ensure the successful completion of this project.

It is my recommendation that Contract No. 13-535 be awarded to Abbott & Price, Inc. in the amount of \$329,795.00.
